Terms and Conditions and Liability Waiver

Thank you for registering for TRANSACT (the "Event") hosted by Electronic Transactions Association ("ETA"). By registering for this Event, you agree to the following:

The cancellation deadline for the event, including special events, is March 24, 2023, 11:59 pm,

PST. Refunds will be subject to a \$100 processing fee plus \$50 for each special event registered for. No refunds will be issued after the cancellation deadline. No-shows are non-refundable

Golf Tournament Terms & Conditions: The deadline to register for the TRANSACT Golf Tournament is March 24, 2023. Entries are accepted on a first-come, first-served basis via this online registration form. All golfers must be registered attendees of TRANSACT. Dress code is casual with soft spikes required.

Golfers will be responsible for any additional charges such as club/shoe rental and merchandise purchases. Foursome requests cannot be honored if individuals are not registered for TRANSACT. If you have a foursome request, email it to: registration@electran.org. Space is limited and based on availability. Golfers will be notified of their pairings on the day of the tournament. Golf cancellations made on or before March 24, 2023, will receive a full refund of fees paid less a \$50 processing fee.

Visa Celebration & ETA Star Awards: The deadline to register for the TRANSACT is April 17, 2023. All participants of the Visa President's Celebration & ETA Star Awards must be registered attendees of TRANSACT. Space is limited and based on availability. Visa President's Celebration & ETA Star Awards cancellations made on or before March 24, 2023, will receive a full refund of fees less a \$50 processing fee.

Terms and Conditions and Privacy Policy Specific to TRANSACT Mobile App: By registering for the TRANSACT mobile app, whether through a mobile device, mobile application or computer (collectively, the "Service") you agree to be bound by these Terms of Use and the Privacy Statement that can be found here. ETA may collect Personal Information, including Sensitive Data, and other information. "Personal Information" means individually identifiable information that would allow us to determine the actual identity of, and contact, a specific living person. By providing Sensitive Data to us, you consent to the collection, use and disclosure of Sensitive Data as permitted by applicable privacy laws. We may collect this information through a website, mobile application, or other online services. By registering for TRANSACT, you are authorizing us to gather, parse and retain data related to the provision of the Service. When you provide personal information through our Service, the information may be sent to servers located in the United States and countries around the world.

Information Shared with Other Users. When you register as a user of the TRANSACT mobile app, your profile will be viewable by other registrants of TRANSACT. Service providers. We may share information, including personal and financial information, with third parties that perform certain services on our behalf.
